



### **GPS MONTHLY/WEEK RENTAL AGREEMENT**

I (print name) \_\_\_\_\_ understand that by initialing each clause below I signify my agreement with each clause.

Upon sending this agreement by fax, email, or US Mail to Bejars Investigation Services LLC, I will be charged (select amount) \$600.00 \_\_\_\_\_ per week or \$ 2,000.00 \_\_\_\_\_ per month rental fee for a GPS device with a magnetic and a one –time 100% refundable deposit of \$600.00 for a total of \$1200.00 for te weekly plan or \$2,600.00 for the monthly plan. This amount is the first payment. Subsequent payments of \$ 600.00 or \$2,000 will be charged weekly/monthly. (Initial here) \_\_\_\_\_.

My \$600.00 deposit is to cover possible damages/loss of GPS unit and is 100% refundable upon my return of my GPS unit in work conditions. If my product is deemed damaged upon return to Bejars Investigations LLC, my deposit will forfeited and not refundable. (Initial here) \_\_\_\_\_.

If I fail to return the GPS unit, regardless of the reason, my deposit will not be refunded. I may be responsible for additional hardware or accessory charges. (Initial here) \_\_\_\_\_.

My rental period begins upon receipt of the GPS device. In the event of shipping errors, Bejars Investigation Services LLC, will amend my rental period to reflect the date of the delivery. If I do not accept delivery, I will be charged the amount equivalent to my payment selection of one week or one month to cover processing, shipping, and inventory expenses. I will be charged \$6,000.00 or \$ 2,000.00 equivalent to one week or one month of rental depending on the payment type I selected above if for any reason I fail to return the GPS device when required. (Initial here)\_\_\_\_\_.

My monthly/weekly rental fee is not prorated and there will be no partial refund given if I return my GPS device early. My billing information and personal information will be kept confidential and will not be disclosed to any third parties. (Initial here)\_\_\_\_\_.

The failure of client to adhere to any above called payments shall give Bejars Investigation Services LLC, the option of ceasing all services and does not entitle client to any of the fees already earned. In the event client fails to pay for the services a agreed after 15-days grace period, client shall be determined to be in “default” and will at that point be determined to be a “collection account”. Client shall be liable for collection costs of 20% of the gross amount due and this amount shall be added on the principal, inclusive of 10% interest plus any and all attorney fees from the first billing and/or non-payment date. Client agrees that in the event of any litigation regarding fees owed to Bejars Investigation Services LLC, that jurisdiction and venue shall be in San Diego County, California. This agreement will be governed by and construed in accordance with the laws of the State of California, County of San Diego. Client agrees to indemnify, defend and hold harmless Bejars Investigation Services LLC, and it’s agents against any liability claims, suits, losses, cost and legal fees caused by the Client’s use of this GPS device.
